

RULE CHANGES – OCTOBER 2009

The following summary was written to help with understanding the proposed rule changes. It is not meant to be the actual rule. Please refer to the September Newsletter for the actual proposed wording. Rule changes that were passed are further explained in this newsletter.

#1 - **PASS 21/FAIL 0** - MCR - (Change) – Super Horse Nominations for the State Show are to be submitted on date with State Show entries. A 15.00 (changed from \$5.00) nomination fee will be sent with form.

#2 - **PASS 12/FAIL 11** - MCR – (Change) - Change the word “mandatory” in the Open Race Event to “optional”.

#3 - **PASS 21/FAIL 0** - MCR – (Correction) - Correct a typo in Pattern #5.

#4 - **PASS 18/FAIL 3** - MCR – (New) - Add that each club provide every rider with a payback slip for 1st – 4th place for each class. (Copy of slips to be provided by secretary.)

#5 - **PASS 21/FAIL 0** - KS 4D – (Change) - Change first pole from starting line from 20’ to 21’, making it standard with most other associations.

#6 - **PASS 16/FAIL 5** - KS 4D – (New) - Optional – Open Age - Rosie Clymer Memorial Ranch Pleasure Event - More natural gait, smooth gait transition, head in normal position.

#7 - **PASS 20/FAIL 0** - SSSC – (New) - Optional – Hunt Seat Equitation Event – Jr. 18 & Under, Sr. 19 & Over – Basically an English Horsemanship Class.

#8 - **PASS 5/FAIL 16** – SFSC – (Change) - Change age groups to Adults 19 - 45, and Adults 46 & over, except Horsemanship - it will remain Adults 19 & Over.

#9 - **PASS 10/FAIL 11** - SFSC – (New) - EKHA would pay ½ of arena rental for the State Show not to exceed \$100.00.

#10 - **PASS 4/FAIL 13** - MCR – (Change) - Making State Show date more flexible - possibly as early as 2 weeks following the last sanctioned EK show - to be voted on in January.

#11 – **NOT VOTED ON/NO LONGER APPLICABLE** – MCR – (Change) - State Show bids must be submitted 60 days before the date of the State Show.

#12 - **NOT VOTED ON/NO LONGER APPLICABLE** - MCR – (Change) - Entry dates for the State Show to be determined by the State Show Secretary as per the date of the State Show.

#13 – **PASS 5/FAIL 17** - MCR – (Change) - Dropping the "double point" system for the State Show.

#14 - **PASS 7/FAIL 13** - MCR – (Change) - Western bridles are to be used, with lead attached to bit. No halters or parade equipment.

#15 - PASS 1/**FAIL 20** - SSSC – (Change) - Buy a "rushed" membership the day of show - throwing out the 30 day rule at a fee to be determined by the host club not to exceed 50.00.

#16 - PASS 0/**FAIL 21** - SSSC – (Change) - For show bill - EK Show is for members only, and ADD: contact information for membership inquiries to the host club. (How to join?)

#17 - PASS 0/**FAIL 20** - SSSC - (Change) - From siblings and stepsiblings only to ride same horse in timed events to the whole family -- grandparents, aunts/uncles, cousins, etc.

#18 - PASS 3/**FAIL 14** - SSSC – (Change) - Two qualified judges for judged events at the State Show AND Rules Committee and State Show Committee will judge timed events.

#19 - **NOT VOTED ON/NO LONGER APPLICABLE** - SSSC – (Change) – Under the two judge system, points will be combined from each judge on a scale of 1st (4), 2nd (3), 3rd (2), and 4th (1), meaning a total of 8 points are possible, depending on how each judge places you. (1st (4) under one judge, 2nd (3) under the other judge would earn you 7 points.)

#20 – PASS 2/**FAIL 19** - SSSC – (Change) - Changing adult classes to 19 & Over. Add having a separate class for "Select Adults 50 & Over" in all multi age events. Participation in the "Select Adult" class would not preclude participation in the Adult 19 & Over division in the same show.

#21 - **NOT VOTED ON/NO LONGER APPLICABLE** - SSSC – (Change) - Showmanship would be 1 - 9, 10 - 13, 14 - 18, Adult 19 & Over, and Select Adult 50+.

#22 - **NOT VOTED ON/NO LONGER APPLICABLE** - SSSC – (Change) - Horsemanship ages - same as #21.

#23 - **NOT VOTED ON/NO LONGER APPLICABLE** - SSSC – (Change) - Adult Age groups 19 & Over, and Adults 50 & Over. Needs changed in Point System, Year End Awards, Point Keeper Check Sheet, Rules and Regulations for Timed Events & any place else that deals with age splits.

#24 - **NOT VOTED ON/NO LONGER APPLICABLE** - SSSC – (Change) - Adult Age groups 19 & Over, and Adults 50 & Over for Judged Events.

#25 - **NOT VOTED ON/NO LONGER APPLICABLE** SSSC – (Change) - All Judged Events, except Showmanship & Horsemanship - Age groups shall be Adults - 19 & Over - Allow parade equipment, allow riders to be in 19 & Over AND Select Adults 50 & Over.

#26 - **NOT VOTED ON/NO LONGER APPLICABLE** - SSSC – (Change) - Stockhorse Pleasure becomes Select Adult Western Pleasure 50 & Over?
